2. Minutes Approval

3. Discussion and recommendation to the Village Board on the approval of the Abbreviated Procedure for Small Subdivisions-Wettstein Plat

Ann Sasso explained the Village engineer has reviewed the plat and has sent a letter noting acceptance. The letter states the plat appears to qualify for the abbreviated procedure for small subdivisions which allows the subdivider of any proposed subdivision having four (4) or fewer lots fronting on an existing street complying with the standards imposed by this title may at the discretion of the Planning Commission submit a final plat for direct consideration and approval by the plat officer without following the steps which ordinarily precede the submission of a final plat.

As long as the Planning Commission agrees with the abbreviated procedure the Wettstein Final Plat meets the Village's regulations.

A motion was made by Bill Waters to recommend to the Village Board the approval of the abbreviated procedure for small subdivisions for the Wettstein Plat. The motion was seconded by John Taylor. **Motion passed #2.**

Ann Sasso noted the final plat approval would on the Special Village Board agenda on May 31st.

4. Discussion and recommendation to the Zoning Board of Appeals on a Solar Ordinance

Ann Sasso noted the draft solar ordinance includes comments from the last meeting for additional discussion. The Planning Commission had some recommended changes. The draft ordinance will be discussed at the June meeting for a recommendation to the ZBA.

5. Discussion and recommendation to the Zoning Board of Appeals on a Screening Ordinance
