- 3. Discussion and recommendation to the Village Board on the approval of the Abbreviated Procedure for Small Subdivisions-Diamond Oaks Village Phase 4

The letter states the plat appears to qualify for the abbreviated procedure for small subdivisions which allows the subdivider of any proposed subdivision having four (4) or fewer lots fronting on an existing street complying with the standards imposed by this title may at the discretion of the Planning Commission submit a final plat for direct consideration and approval by the plat officer without following the steps which ordinarily precede the submission of a final plat.

As long as the Planning Commission agrees with the abbreviated procedure the Diamond Oaks Village Phase 4 Plat meets the Village's regulations.

A motion was made by Jim Willerton to recommend to the Village Board the approval of the abbreviated procedure for small subdivisions for the Diamond Oaks Village Phase 4 Plat subject to approval of the construction plans for the sidewalk. The motion was seconded by Bill Waters. **Motion passed #2.**

Ann Sasso noted the final plat approval would on the Village Board agenda on June 21st.
