2. WWTP No. 1 Peak Flow Control Phase 1-Project Status Update

Scott DeSplinter gave an update on WWTP No. 1 Peak Flow Control Phase 1. The project is out to bid and there's a pre-bid meeting on November 17th at 1:00 p.m. The bid opening will be on December 4th at 10:00 a.m. During construction there could be one potential problem in that they might not be able to do the directional drilling and may have to switch to an open cut but we won't know that until they get into the construction.

3. WWTP No. 1 Peak Flow Control Phase 1-Recommendation to the Village Board on the engineering amendment for wetland investigation and construction phase services

Scott DeSplinter explained the engineering amendment for the wetland investigation and construction phase services.
