Jeff DeGroot opened the public hearing at 6:03 p.m. and noted the public hearing is for the GHAA property annexation agreement. There was no one in attendance. The public hearing was closed at 6:03 p.m.

## 4. Public Hearing-Annexation Agreement-Points Property

Jeff DeGroot opened the public hearing at 6:04 p.m. and noted the public hearing is for the Points property/Germantown Hills School District #69 annexation agreement. The school took ownership on November 1<sup>st</sup>. There was no one in attendance. The public hearing was closed at 6:04 p.m.

### 7. Current Agenda Items

# a. Approval of the Annexation Agreement for the GHAA Property

Bill Streeter indicated that unless and until the school owns the property based on the election results being certified, this agreement will not be completed. A closing date has not been set yet. The property will be rezoned residential with a special use for school purposes. The board has already committed to the costs in the intergovernmental agreement. The annexation allows for the billboards and the board will consider an amendment to the village code to allow the billboards on this property. The village's welcome sign is also being allowed as a part of the annexation agreement.

A motion was made by Todd Rice to approve the annexation agreement for the GHAA property. The motion was seconded by Heather Armistead. **Motion passed #2.** 

### b. Approval of the Annexation Agreement for the Points Property

Bill Streeter noted that the school district already owns this property and the rezoning and special use have been recommended and are a part of the annexation agreement.

A motion was made by Stephanie Chaon to approve the annexation agreement for the Points Property now owned by the Germantown Hills School District #69. The motion was seconded by Karl Figg. **Motion passed #3.** 

# c. An Ordinance Amending the Germantown Hills Village Code, Village of Germantown Hills, Illinois Regarding Sign Regulations (Billboards)

Bill Streeter explained that this code change will allow for billboards only in specific circumstances.

A motion was made by Nathan Henricks to approve Ordinance #853 an Ordinance amending the Germantown Hills Village Code, Village of Germantown Hills, Illinois Regarding Sign Regulations (Billboards). The motion was seconded by Tom Eckstein. **Motion passed #4.** 

# d. Approval of the revised software as a Service Agreement (GIS Mapping System) with CMT

Bill Streeter had made a revision to the proposed agreement and had asked for clarification on some questions. The board discussed and would like a 3-year fixed cost on the license fee of \$7,500. Scott DeSplinter noted he would check with Eric. The board agreed to defer until the December meeting.

## e. Approval of the Tax Levy Ordinance for FY 22-23

Todd Rice shared that over the last few years that he has been on the board the board has not raised taxes.

Ann Sasso explained the levy account balances and the proposed levy for the next year. The board agreed to keep the levy at same total tax dollars.

A motion was made by Karl Figg to approve Ordinance #854 the Annual Tax Levy Ordinance for FY 22-23. The motion was seconded by Todd Rice. **Motion passed #5.** 

#### f. Approval of the Christmas Bonus for all village personnel

The board discussed what the previous Christmas bonus has been. Todd Rice recommended the board gross up to get each employee a specific amount.

A motion was made by Nathan Henricks to approve a Christmas bonus of a net of \$350 per employee. The motion was seconded by Stephanie Chaon. **Motion passed #6.**

- a. Zoning Officer/Village Clerk/Village Administrator-Ann Sasso stated there is a fence violation that will need to be addressed by the attorney as the resident isn't responding. There's also a variance request that will on the ZBA's agenda for an addition in the White Oak Lake Subdivision.
- **b. Director of Public Works-**Rich Brecklin stated the software is outdated on the radar signs. The snowplow equipment is ready, and we have salt on hand with more coming in with the salt contract. One truck was ordered but we are going to look to add another building to get the village's equipment indoors. The bank stabilization at both plants is going well along with the German Hills lift station project. Rich noted we still need to get the sludge hauled away, but the company is having staffing issues. Rich stated he has a way to get it under the cover until something can be done with it in the spring as the sludge is too wet now.

Scott DeSplinter met with the Mother House about the sewer. We need to finalize the agreement.

Rich Brecklin stated he is having surgery on his knee in December and will be out for a while.
